

# {{Guide}}What is the Cancellation Policy of Frontier Airlines?

Frontier Airlines is known for its ultra-low fares, but plans can change unexpectedly. If you're wondering whether it's possible to cancel a Frontier flight after the initial 24-hour window, the answer is yes—though there may be fees and limitations. ## Can you cancel Frontier after 24 hours?

Cancel within 24 hours of booking (with a 7-day lead time) for free. After that, expect applicable fees. Free cancellation is possible within 24 hours if booked 7+ days before departure; otherwise, charges apply.

Frontier follows the U.S. Department of Transportation's rule allowing passengers to cancel a booking within 24 hours of purchase for a full refund, as long as the flight is at least 7 days away **[1-888] • [287] • [4045]**.
